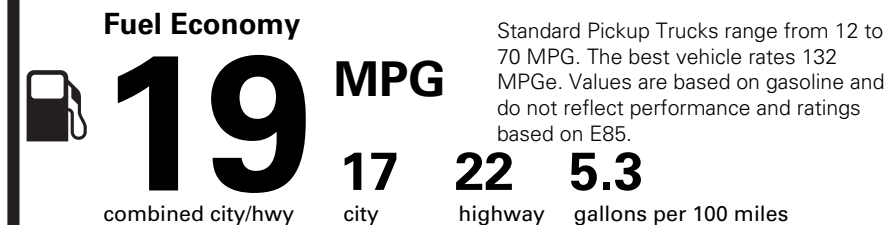

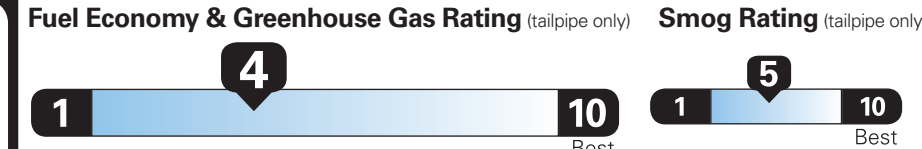
E85 Flexible-Fuel Vehicle Gasoline-Ethanol (E85)
