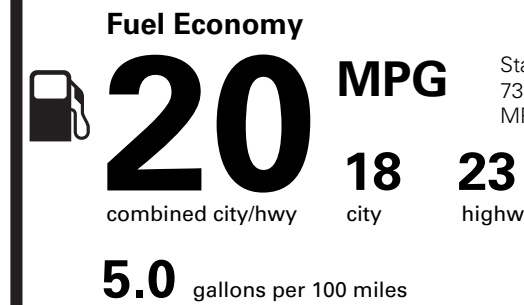

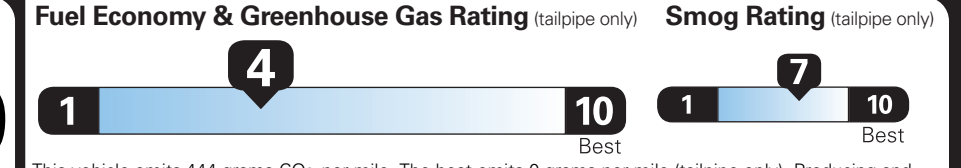
Gasoline Vehicle
