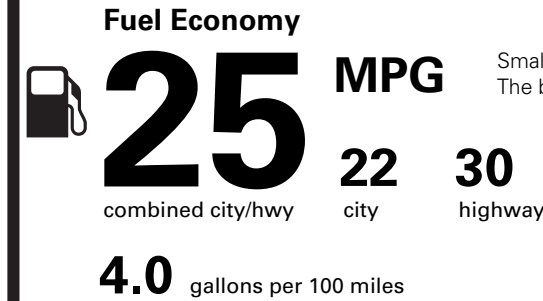

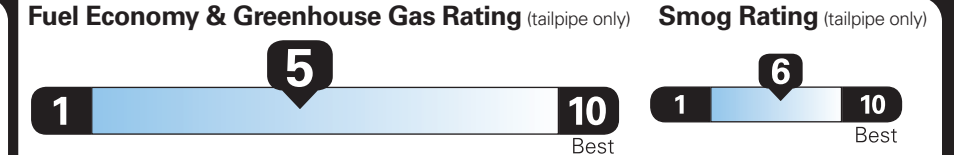
Gasoline Vehicle
